

# **Internship offer: International Policy**

## **Description of the organisation**

The Ocean & Climate Platform (OCP) is a multi-stakeholder network with more than 90 international members: NGOs, scientific organisations, universities, research institutions, foundations, public institutions, business associations and local authorities. OCP's objective is to raise awareness among the public, scientists and political decision-makers of the importance of the interlinkages between Ocean, Climate and Biodiversity.

#### The intern's responsibilities will include:

- Assist with the coordination of advocacy activities, especially regarding the oceanclimate-biodiversity nexus (e.g. ocean-based mitigation and adaptation solutions)
- Assist with the coordination of mobilisation activities as part of the Marrakech Partnership Global Climate Action on Ocean and Coastal Zones, including the Ocean Action Day during UNFCCC COP 27
- Assist with the organisation of international conferences, meetings and workshops, in particular the UNFCCC COP 27 (Sharm El Sheikh, November 2022) and CBD COP15 (Kunming, Fall 2022),
- Follow-up of the relations between the Platform and national institutions (e.g. Ministry for the Ecological Transition, Ministry of the Sea), European institutions (e.g. European Parliament), and international institutions (e.g. UNFCCC)
- Follow-ups of international processes (e.g. NDC revision cycle, Global Stocktake) and conferences, especially UNFCCC and CBD
- Draft a wide range of information materials, including meeting reports, factsheets, blog articles, policy briefs and conference documents
- Conduct independent research on ocean-climate-biodiversity related topics of interest, e.g. marine protected areas, blue carbon ecosystems, shipping etc.

## **Skills and qualifications:**

- Excellent command of both <a href="English">English</a> and <a href="French">French</a> (oral and written)
- Excellent writing skills and ability to work with little supervision
- Strong organisational skills and attention to details
- Strong knowledge of international environmental affairs and governance (ocean, climate and biodiversity)
- Strong research and analysis skills

**Academic background:** Be enrolled in a <u>masters' degree</u> in environmental policy, political science, international relations or equivalent.
